'We're the legend of Halloween.'

Ripley couple enter a whole new dimension when it comes to Halloween uge skeletons at the front gate. Giant spiders crawling over the front porch. Tombstones. A huge skull at the front door. Eerie blue lights and lots of fog.

Enter the domain of the 100-year-old Barbee Mansion at 162 S. Main St. in Ripley – *if you dare*. Quickly walk past the ghostly creatures. Don't get caught in the spider webs. Refuse to see if it's your name on one of the tombstones.

Your treat – unless you plan a few tricks yourself – is a greeting from Chad and Rachael Lowry, the human denizens of the historic home.

Most people celebrate Halloween with some decorations, candy or maybe a small party. The Lowrys, however, have taken Halloween to a new level.

"We've always done big Halloween displays," Chad said, "but it took on a whole new persona last year."

Built in 1908, the Barbee Mansion provides the perfect setting for Halloween. The Lowrys were living in Drummonds when they saw the mansion for sale on the Zillow website. They bought it the first time they walked through the home. As a part of the purchase, they kept the Barbee Mansion Facebook page: www.facebook.com/barbeemansion.

Each year, starting on the first of October, Chad

and Rachael decorate the entire house, inside and out. Their two grown sons no longer participate, but this year they have enlisted the help of their two nephews, Noah and Nicholas Lowry, who live nearby in Burlison, Tenn.

Though it isn't easy finding the large decora-

tions for sale, Chad adds to his Halloween display each year. He purchased a giant spider and a giant pumpkin head this year on Home Depot's website at 2 a.m. one morning.

"You can hardly get them," he said. "They are gone within minutes. I just happened to check and sure enough found them; Home Depot has the absolute best Halloween decorations every year."

His wife puts a foot down on having coffins in the yard, Chad said, "but you never know."

Chad also calls himself "a big Costco guy." That's where he buys the full-size candy bars to give away to trick-or-treaters.

Last year, 500 children showed up. Because the Lowry house is located right off the Ripley Court Square, many families came from Ripley's Trunk or Treat event. People who drive can park across the street on the Methodist Church parking lot, Chad said. Police will be on hand to direct traffic.

This year, Chad and Rachael will open their doors at 5:30 p.m. on the night Ripley celebrates Halloween. They stop handing candy out when people stop coming to their door.

Mysteriously, all of the decorations will be gone and stored under the house by noon the next day.

"We are the legend of Halloween," Chad said. "We have always loved Halloween. We like interacting with the kids. It's a great time." ■

Son's Death a Catalyst for Helping Others

That started out as a way to help cover funeral costs for Scott and Melissa's 19-year-old son, Colton, has become annual fundraisers to help other children.

"We put on horse shows, rodeos and point shows every other Friday night," said Scott, a lineman at Ripley Power and Light.

Scott and Melissa were overwhelmed by the support they received from friends and family members after Colton died in 2016. They offered to put on a rodeo in Colton's memory to help defray funeral costs.

A rodeo was a great way to remember Colton, who was an avid bullrider.

"I didn't know what I was going to do after we lost Colton," Scott said. "Then

Melissa and I started talking. My buddies helped us out so much. We decided to have a memorial rodeo each June to help other children."

Events include bullriding and barrel racing. Each year, funds raised at the rodeo go to three children who need help financially to fulfill their dreams and compete in the international rodeo.

The memorial rodeo is in the Flying H Arena in Halls, which was built by Scott and his buddies, after another arena was torn down. The arena also hosts a Hope Fund horse show,

which benefits children being treated at St. Jude Children's Research Hospital.

The Point Show held every other Friday night allows young riders to accumulate points for how well they do. At the end of the year, points are tallied and the riders receive prizes. "If we can touch a kid and keep him or her off the street and on a horse, we feel like we've done something," Scott said.

The Ozments have two other children, Mollie, 17, and Tucker, 14. Everyone participates in the horse events, said Scott, who said he was still in diapers when he first starting riding on his family's farm.

For Scott and Melissa it's all about family and friends. People who can help others.

"Everyone loved Colton," Scott said. "He was a joker. He loved to hunt, he loved riding horses and he loved bull riding. He would love what we are doing, too." ■

How street lights work

Street lights have controls that are sensitive to sunlight. A lack of sunlight causes a circuit within the street light to turn the light on at night or in dark weather.

We need your help

Let us know when you see:

- A street light off at night.
- A street light burning during the day when the weather is not cloudy or overcast.
- A street light flickering on and

It is important to give the pole number and street name for the light and any other details about the location. We will repair the light as quickly as possible.

Costume Safety

- All costumes, wigs and accessories should be fire-resistant.
- If children are out after dark, fasten reflective tape to their costumes and bags, or give them glow sticks.
- Halloween makeup should be nontoxic; test it in a small area first; remove it before children go to bed to prevent skin irritation.

On the Prowl

Children are more than twice as likely to be hit by a car and killed on Halloween than on any other day of the year. Lack of visibility because of low lighting at night also plays a factor in these incidents.

- A responsible adult should accompany young children.
- If your older children are going alone, plan and review a route acceptable to you.
- Agree on a specific time children should return home.
- Teach your children never to enter a stranger's home or car.
- Instruct children to travel only in familiar, well-lit areas and stick with their friends.
- Tell your children not to eat any treats until they return home.
- Children and adults are reminded to put electronic devices down, keep heads up and walk, don't run.

Light up your night with a Ripley Power backyard light

A security light leased from Ripley Power and Light Company adds that extra light to your yard and property to give you added security and allow you to enjoy the outdoors after dark.

Our LED lights are triggered by photocells that are sensitive to darkness. The lights come on at dusk and turn off at dawn.

We will install your security light for free and then maintain the light for a monthly leasing fee of \$13.32 that is added to your monthly utility bill. We require a five-year lease.

Meanwhile, if you already own a security light, let us know if the light starts to blink on and off, so that we can fix it before it goes out.
